## SACRAMENTO CAMPUS - COVID SAFETY PROCEDURES



*Keeping our community safe and healthy will require patience, consideration and empathy. We know Graduate School of Management community members are up for the challenge. As state guidance has changed, the GSM is operating under Limited Operations.*



### BEFORE YOU ARRIVE AT THE SACRAMENTO CAMPUS

Please assess how you are feeling. **DO NOT COME TO CAMPUS IF YOU ARE NOT FEELING WELL.** Err on the side of caution. Your professors and organization leaders will not penalize you for staying home.

**While on campus and in the building, we expect you to follow these guidelines:**

- Complete the [Daily Symptom Survey](#) before arriving to campus.
- **Everyone is required to wear face coverings indoors, regardless of vaccination status.**
- If a person is fully vaccinated, the only time a face covering can be removed indoors is when that person is alone in an office or a cubicle. If a person is unvaccinated, they must wear a face covering indoors at all times and outdoors in crowded spaces.
- Starting September 20, **fully vaccinated individuals must undergo asymptomatic testing every 14 days** in order to be in compliance and gain access to campus facilities. **Unvaccinated individuals must get tested every four days.** You can be tested at the UC Davis Health Administration Support Building and can [make an appointment online](#).
- You may remove your face covering briefly to eat or take a quick drink. Eating is allowed in employee breakrooms, private offices, and campus dining locations. Unvaccinated individuals are required to maintain physical distance while eating or drinking in a breakroom setting.
- The GSM is providing hand sanitizing stations throughout the suite for your convenience.
- Employees and students must report a COVID-19 diagnosis for themselves or someone with whom they share a residence. To report a positive case or concern, email [reportcovid@ucdavis.edu](mailto:reportcovid@ucdavis.edu). You may also visit the [Campus Reporting](#) website for more information
